**Course Description**: This course is a study of the functions performed in the American system of state governments, with special reference to the development of governance in Texas and its Constitutions. This course satisfies the Legislative requirements for teacher certification.

Course Purpose: Government 2306, as taught at South Plains College, is a reading intensive course designed to acquaint the learner with the origin and development of the Texas Constitution, structure and powers of state and local government, federalism and intergovernmental relations, political participation, the election process, public policy, and the political culture of Texas. This course meets the statutory requirements as set forth by the state of Texas.

Essay: You will have an essay assignment for this course and will be 10% of your grade. The topic choices, instructions, and due date will be posted on Blackboard. Your grade will be determined by a rubric included at the end of the syllabus which also includes the instructions for the assignment. These will be turned in via email (bbearden@southplainscollege.edu).

<u>Discussion Postings:</u> Three times throughout the semester you will write a discussion post which will be your reaction to an article related to U.S. government and reply to a classmate's discussion. You must submit your post before replying to classmates, any failure to do so will result in a loss of 30 points.

- These original posts must be at least 400 words in length.
- Additionally, you must also reply (150 words) to one of your fellow classmates' posts to receive full credit.
- A full rubric and instructions can be found at the end of this syllabus.

Quizzes: Five times throughout the semester you will have a quiz. Quizzes will be short and consist of 15 multiple choice questions regarding current topics from both readings and lectures. These will be time quizzes and students will be given 15 minutes to take these quizzes, so make sure that you are prepared.

Exams: Three times throughout the semester students will be given an exam. This includes your final exam. These exams will consist of 50 multiple choice questions and you will have 50 minutes to complete. These exams will account for 50% of your grade.

#### Course Requirements, Expectations, and Policies

Late Work/Extra Credit: You will NOT have the opportunity to earn extra credit points during the course, so do not ask. No late work will be accepted since you have ample time to complete assignments.

**Drop Policy:** If you have not completed an assignment before the first unit closes, you will be dropped. Likewise if you miss more than four assignments before the drop date you will be dropped.

**Disruption of Classroom Environment**: Your professor will not tolerate any disruption of the classroom environment. This includes any problems your facilitator encounters with you AND hateful/disrespectful remarks made in the classroom, on discussion postings, email, or chat. I will drop you with an F for violation of this policy.

**Emailing Your Professor:** I require students to send a professional email when contacting me. If you send an unprofessional email to me, I will not respond. In addition, do not attempt to argue with me over a grade you receive, if you do I will either lower your grade further, or drop you with an F.
